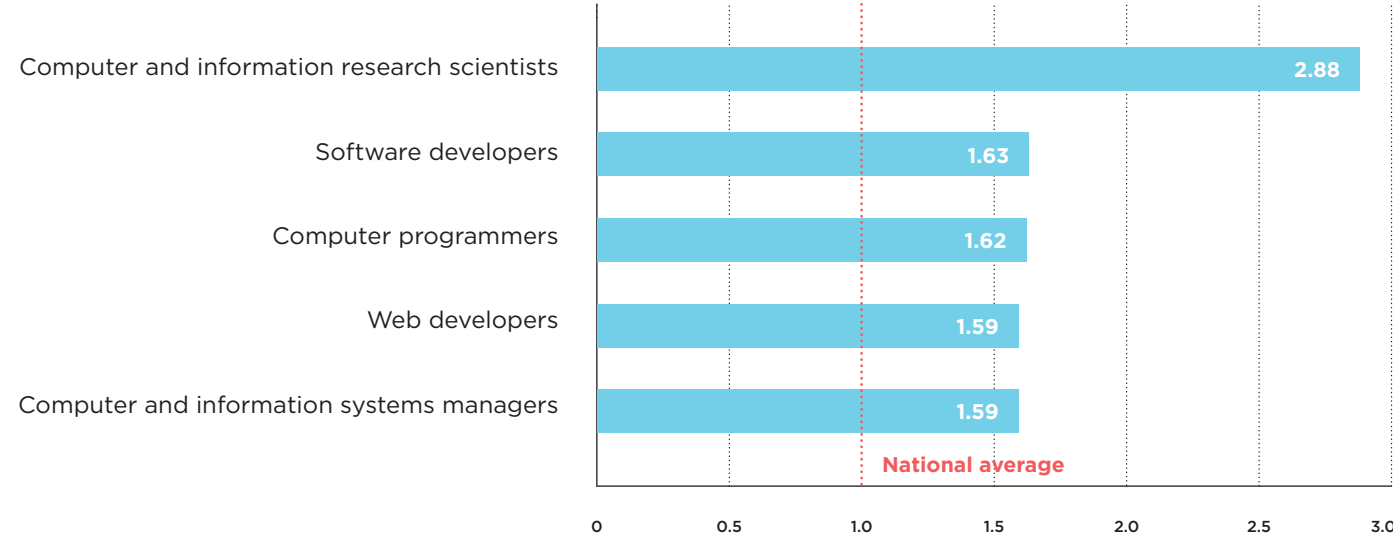

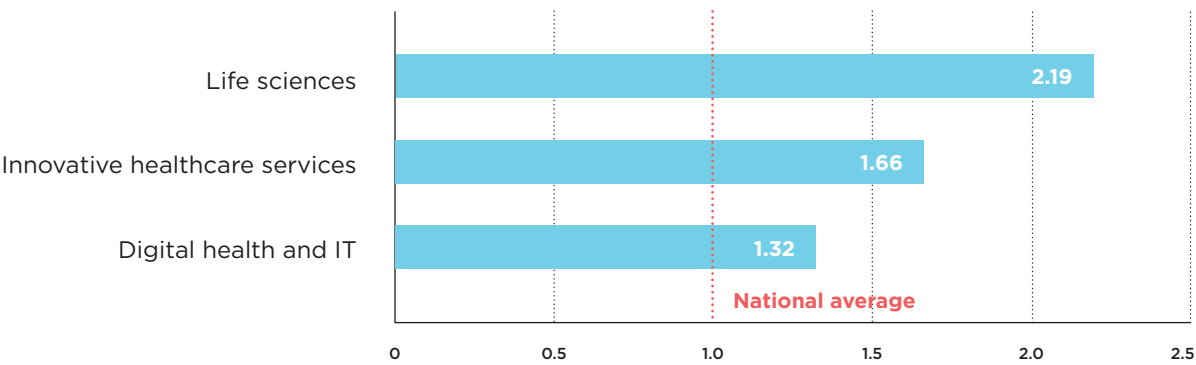


HEALTHCARE INNOVATIONS

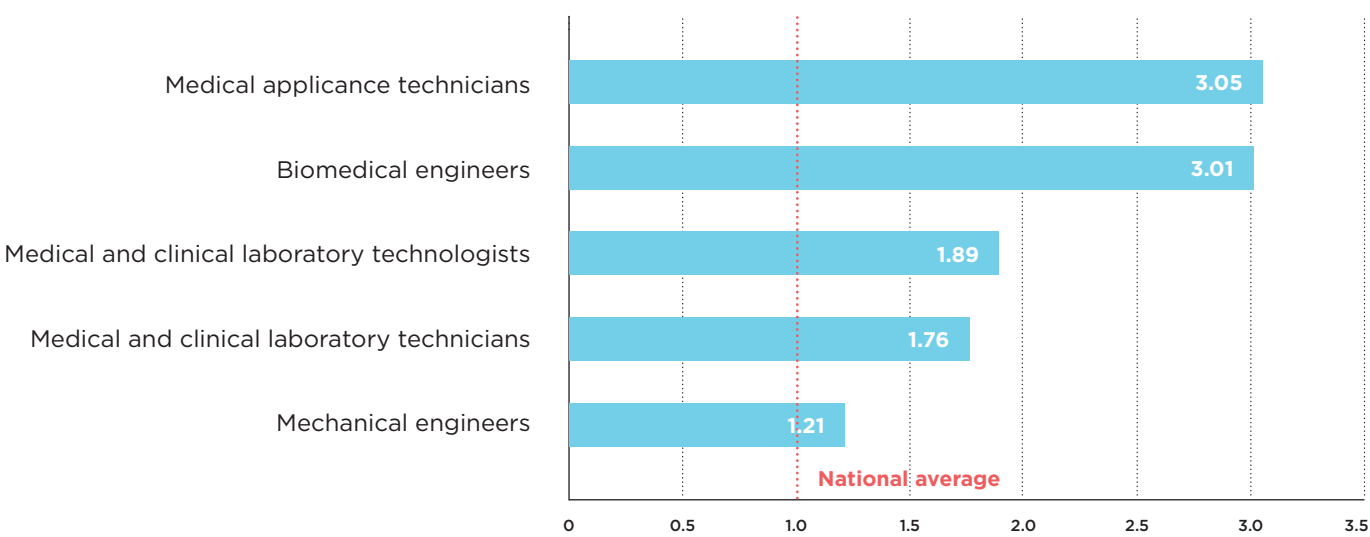

**University of Utah**  
Established in 1850 as the University of Deseret by the General Assembly of the provisional State of Deseret, making it Utah's oldest institution of higher education, It received its current name in 1892, four years before Utah attained statehood, and moved to its current location in 1900.

The "U" is a public flagship research university in Salt Lake City, Utah. As of Fall 2019, there were 24,485 undergraduate students and 8,333 graduate students, for an enrollment total of 32,818.



**Westminster College**  
Westminster is a private, non-profit, accredited, and comprehensive liberal arts college. Students experience the liberal arts blended with professional programs in an atmosphere dedicated to civic engagement.

Westminster is located in the eclectic Sugar House neighborhood of Salt Lake City. Total enrollment (2019-20 academic year): 2,215 1,740 undergraduate students, and 475 graduate students.



**Salt Lake Community College**  
Salt Lake Community College is Utah's largest college. It serves more than 60,000 students on 10 campuses and with online classes. All ages. Many interests. Flexible scheduling. With an exceptional range of academic and career-oriented options.

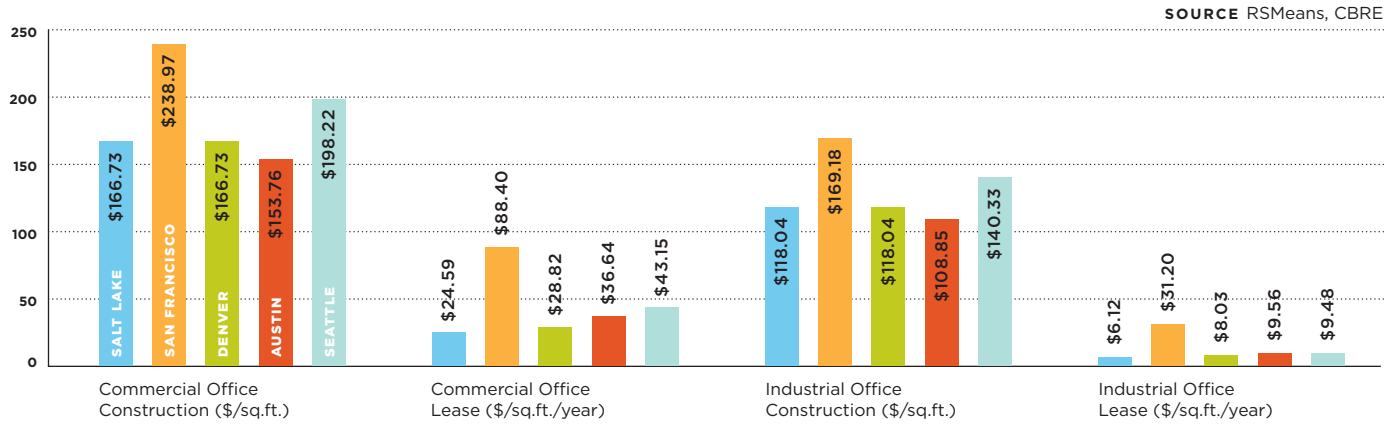
